In FY 2024, THRIVE strengthened its mission to ensure children in extreme poverty have reliable access to nutritious daily school meals. Through our hyper local partnerships with schools, families, and community leaders, THRIVE delivered 383,150 school meals to 2,425 students across underserved communities in Bangladesh and the Philippines. These school meals directly improved children's ability to learn and stay in school. Partner schools reported an average attendance rate of 94 percent, reflecting the stabilizing impact of consistent nutrition on student participation. Enrollment across THRIVE supported schools increased by 10 percent, as families recognized the value of a dependable daily meal in supporting their children's education, health, and long term opportunities. By focusing on school meals as a proven, high impact intervention, THRIVE continues to reduce child hunger, strengthen educational outcomes, and help children thrive in the world's most vulnerable communities.
